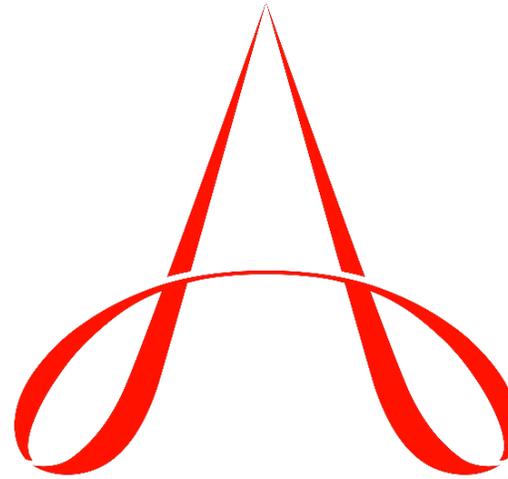

## **Milestones Supplemental Guide**

This document provides additional guidance and examples for the Gastroenterology Milestones. This is not designed to indicate any specific requirements for each level, but to provide insight into the thinking of the Milestone Work Group.

Included in this document is the intent of each Milestone and examples of what a Clinical Competency Committee (CCC) might expect to be observed/assessed at each level. Also included are suggested assessment models and tools for each subcompetency, references, and other useful information.

Review this guide with the CCC and faculty members. As the program develops a shared mental model of the Milestones, consider creating an individualized guide (Supplemental Guide Template available) with institution/program-specific examples, assessment tools used by the program, and curricular components.

<b>Patient Care 1: Data Gathering and Non-Procedural Diagnostic Testing</b> <b>Overall Intent:</b> To use history and physical exam and appropriate diagnostic testing to evaluate patients	
Milestones	Examples
<p><b>Level 1</b> <i>Accesses data and gathers a history standard for general internal medicine</i></p> <p><i>Performs a physical examination standard for general internal medicine</i></p> <p><i>Selects and interprets diagnostic tests, with significant assistance</i></p>	<ul style="list-style-type: none"> <li>● Obtains a general history and performs a general physical exam on a patient presenting with symptoms of anemia and orders a complete blood count (CBC) and iron panel</li> </ul>
<p><b>Level 2</b> <i>Gathers a symptom-specific history and data, with assistance</i></p> <p><i>Performs a symptom-specific physical examination, with assistance</i></p> <p><i>Selects and interprets diagnostic tests, with moderate assistance</i></p>	<ul style="list-style-type: none"> <li>● After discussing the patient with the attending, obtains a gastroenterology (GI)-specific history, performs a rectal exam and recommends an upper endoscopy and colonoscopy</li> </ul>
<p><b>Level 3</b> <i>Gathers data from multiple sources and collects symptom-specific history, including psychosocial issues</i></p> <p><i>Performs a symptom-specific physical examination, without assistance</i></p> <p><i>Selects and interprets diagnostic tests, with minimal assistance and general awareness of cost effectiveness and patient preferences</i></p>	<ul style="list-style-type: none"> <li>● Inquires about family history of peptic ulcer disease and colon cancer, personal history of alcohol use, and obtains prior CBC values</li> <li>● Examines a patient with abnormal liver tests for cutaneous stigmata of chronic liver disease without direction from the attending</li> <li>● Orders an <i>H. pylori</i> breath test on a young patient with dyspepsia and no alarm features instead of performing an endoscopy</li> </ul>
<p><b>Level 4</b> <i>Consistently synthesizes data from multiple sources</i></p> <p><i>Consistently performs a symptom-specific physical examination</i></p>	<ul style="list-style-type: none"> <li>● Consistently requests prior records on patients presenting with abdominal pain</li> <li>● Evaluates for pelvic floor dysfunction during the rectal exam on patients presenting with constipation</li> </ul>

<p><i>Independently selects and interprets diagnostic tests, with adjustments based on cost effectiveness and patient preferences</i></p>	<ul style="list-style-type: none"> <li>● Recommends noninvasive tests for colorectal cancer screening in a patient who refuses colonoscopy</li> </ul>
<p><b>Level 5</b> <i>Role models gathering and synthesis of clinical information</i></p>	<ul style="list-style-type: none"> <li>● After reaching out to other providers and reviewing medical records, creates a summary and corrects misinformation in the chart</li> </ul>
<p><i>Interprets subtleties of diagnostic test results to improve patient care</i></p>	<ul style="list-style-type: none"> <li>● Evaluates for celiac disease in a patient with elevated liver enzymes</li> </ul>

<b>Patient Care 2: Patient Management in Gastrointestinal and Liver Disease</b> <b>Overall Intent:</b> To develop a comprehensive care plan for gastrointestinal and liver disease based on disease presentation and urgency	
Milestones	Examples
<p><b>Level 1</b> <i>Develops focused care plans, with moderate assistance</i></p> <p><i>Requires direct supervision to prioritize and deliver patient care</i></p> <p><i>Recognizes situations requiring urgent or emergent care, with significant assistance</i></p>	<ul style="list-style-type: none"> <li>● Prescribes an anti-secretory agent for a patient presenting with gastroesophageal reflux disease (GERD) but needs prompting to ask for alarm symptoms</li> <li>● After examining a patient presenting to the emergency department with a GI bleed, speaks with attending about next steps</li> <li>● Immediately calls the attending after the consult is received to determine when to re-evaluate patient</li> </ul>
<p><b>Level 2</b> <i>Develops focused care plans, with minimal assistance</i></p> <p><i>Manages patients with straightforward diagnoses, with minimal assistance</i></p> <p><i>Recognizes situations requiring urgent or emergent care with minimal assistance</i></p>	<ul style="list-style-type: none"> <li>● Orders anti-secretory agent and endoscopy for a patient with GERD and alarm symptoms</li> <li>● Manages patient with chronic abdominal pain, diarrhea and asks attending if endoscopy is indicated</li> <li>● Independently evaluates the patient and confirms with attending the need for urgent endoscopic management</li> </ul>
<p><b>Level 3</b> <i>Independently develops focused care plans</i></p> <p><i>Independently manages patients with straightforward diagnoses</i></p> <p><i>Manages urgent and emergent situations, with minimal assistance</i></p>	<ul style="list-style-type: none"> <li>● Independently synthesizes treatment plan for a patient with inflammatory bowel disease (IBD)</li> <li>● Independently manages a patient with GERD</li> <li>● Independently evaluates the patient and appropriately triages timing of endoscopy</li> </ul>
<p><b>Level 4</b> <i>Modifies care plans based on a patient's clinical course, additional data, patient preferences, and cost-effectiveness principles</i></p> <p><i>Independently manages patients with complex and undifferentiated syndromes and recognizes disease presentations that deviate from common patterns</i></p>	<ul style="list-style-type: none"> <li>● For a patient with IBD, selects injectable therapy vs infusion therapy based on patient preference</li> <li>● Modifies management plan in a patient with IBD who develops complications</li> <li>● Independently develops and implements a plan for steroid taper for a patient with autoimmune hepatitis and monitors response, adjusting steroid dose between visits</li> <li>● Independently manages patients with autoimmune hepatitis with lack of response to steroid therapy suggesting overlap syndrome</li> </ul>

<i>Independently manages urgent and emergent situations</i>	<ul style="list-style-type: none"> <li>● Independently recommends gastric tamponade balloon placement following failed endoscopic hemostasis</li> </ul>
<p><b>Level 5</b> <i>Develops customized, prioritized care plans for complex patients, incorporating diagnostic uncertainty and cost-effectiveness principles</i></p> <p><i>Effectively manages unusual, rare, or complex disorders</i></p>	<ul style="list-style-type: none"> <li>● Diagnoses and treats patient with gastrointestinal bleeding due to innumerable angioectasias of the small bowel</li> <li>● When managing a patient who declines blood products, identifies bloodless therapeutic strategies</li> </ul>
Assessment Models or Tools	<ul style="list-style-type: none"> <li>● Chart-stimulated recall</li> <li>● Direct observation</li> <li>● Medical record (chart) review</li> <li>● Multisource feedback</li> </ul>

<b>Patient Care 3: Procedures: Cognitive Components</b>	
<b>Overall Intent:</b> To understand the indications and contraindications for endoscopic procedures as well as the interpretation of the normal and abnormal findings and therapeutic options, when necessary	
<b>Milestones</b>	<b>Examples</b>
<p><b>Level 1</b> <i>Selects clinically indicated procedure(s), with significant assistance</i></p> <p><i>Recognizes normal and abnormal procedural findings</i></p> <p><i>Identifies immediate interventions and subsequent plan of care, with significant assistance</i></p>	<ul style="list-style-type: none"> <li>● Works with supervising attending to determine whether prepped or unprepped colonoscopy is indicated</li> <li>● Recognizes cecal landmarks and can distinguish the ileocecal valve from a lipoma</li> <li>● Identifies inflamed mucosa such as gastritis or colitis</li> <li>● Identifies a bleeding ulcer and recognizes need for intervention but needs assistance from the attending to determine therapeutic modality and to initiate post-procedure medical therapy after endoscopic control of bleeding</li> </ul>
<p><b>Level 2</b> <i>Selects clinically indicated procedure(s), with moderate assistance</i></p> <p><i>Identifies and interprets abnormal procedural findings, with moderate assistance</i></p> <p><i>Recognizes and selects immediate interventions and subsequent plan of care, with moderate assistance</i></p>	<ul style="list-style-type: none"> <li>● Works with supervising attending to determine urgency of the indicated procedure</li> <li>● Lists a differential for the finding of inflamed mucosa but requires assistance to prioritize that list</li> <li>● Lists options for endoscopic control of bleeding and post-procedural medical therapy</li> </ul>
<p><b>Level 3</b> <i>Selects clinically indicated procedure(s), with minimal assistance</i></p> <p><i>Identifies and interprets abnormal procedural findings, with minimal assistance</i></p> <p><i>Selects appropriate immediate interventions and subsequent plan of care, with minimal assistance</i></p>	<ul style="list-style-type: none"> <li>● Recognizes that a colonoscopy is indicated for a patient presenting with melena and a negative upper endoscopy</li> <li>● Determines the most likely cause(s) of inflamed mucosa</li> <li>● Recognizes that advanced imaging techniques can be used to predict histology of a colonic polyp</li> <li>● Determines best option for endoscopic control of bleeding and initiates post-procedural medical therapy</li> </ul>
<p><b>Level 4</b> <i>Independently selects clinically indicated procedure(s) based on assessment and indications, including capabilities and limitations of the procedure, resources, and risk/benefit ratio for the patient</i></p>	<ul style="list-style-type: none"> <li>● In a patient with melena, consents and orders bowel preparation for a colonoscopy in anticipation that an upper endoscopy may be negative</li> </ul>

<p><i>Independently identifies and interprets abnormal procedural findings</i></p> <p><i>Independently selects appropriate immediate interventions and subsequent plan of care, with recognition of personal limitations</i></p>	<ul style="list-style-type: none"> <li>● Recognizes ischemia as the most likely cause of inflamed mucosa and appropriately aborts the procedure to prevent complications</li> <li>● Consistently uses advanced imaging techniques to assist in endoscopic management</li> <li>● Recognizes a large bleeding vessel that is not amenable to endoscopic therapy and consults interventional radiology and surgery</li> </ul>
<p><b>Level 5</b> <i>Recognizes when a novel or innovative procedure should be considered and seeks out assistance</i></p> <p><i>Identifies and interprets atypical or rare variations during procedures</i></p> <p><i>Suggests and implements innovative and alternative interventions for versatile care plans</i></p>	<ul style="list-style-type: none"> <li>● Recognizes the role of new natural orifice endoscopic procedures and refers appropriately</li> <li>● Identifies characteristics of primary mucosal cancers versus metastatic lesions</li> <li>● Recognizes an ileal carcinoid incidentally found during screening colonoscopy</li> <li>● Recognizes that some perforations can be managed endoscopically and refers for advanced clipping and suturing procedures</li> </ul>

<b>Patient Care 4: Procedures: Technical Components</b>	
<b>Overall Intent:</b> To independently perform required endoscopic procedures (i.e. esophagogastroduodenoscopy (EGD), colonoscopy, (percutaneous endoscopic gastrostomy (PEG) placement), including all aspects of the pre- and post-procedural assessments, therapeutic interventions and follow-up	
<b>Milestones</b>	<b>Examples</b>
<p><b>Level 1</b> <i>Performs peri-procedural assessment, including required diagnostic evaluation and selection of equipment, with moderate assistance</i></p> <p><i>Performs portions of the procedure, with significant assistance</i></p>	<ul style="list-style-type: none"> <li>● Evaluates patient, obtains informed consent, and likely needs attending physician guidance to determine type of endoscopic procedure indicated</li>   <li>● Positions patient appropriately</li> <li>● Intubates the esophagus but not the pylorus</li> <li>● Unable to get past the sigmoid colon</li> </ul>
<p><b>Level 2</b> <i>Performs peri-procedural assessment, including required diagnostic evaluation and selection of equipment, with minimal assistance</i></p> <p><i>Performs significant portions of the procedure, with moderate assistance</i></p> <p><i>Performs portions of the therapeutic interventions, with significant assistance</i></p>	<ul style="list-style-type: none"> <li>● Evaluates patient, determines type of sedation required, obtains informed consent, and determines type of endoscopic procedure indicated; seeks assistance from attending physician when a patient has post procedural abdominal pain</li>   <li>● Reaches cecum after attending reduces the loop and recommends abdominal pressure</li>   <li>● Selects a clip for ulcer bleed but unable to deploy in adequate location for hemostasis</li> </ul>
<p><b>Level 3</b> <i>Independently performs peri-procedural assessment, including required diagnostic evaluation and selection of equipment in standard cases</i></p> <p><i>Performs the complete procedure to intended extent, including thorough visualization/examination, with minimal assistance</i></p> <p><i>Performs most standard therapeutic interventions, with minimal assistance</i></p>	<ul style="list-style-type: none"> <li>● Manages a patient with post procedural abdominal pain and recommends imaging to rule out a perforation</li>   <li>● Reaches the cecum with verbal coaching only</li>   <li>● Performs biopsy, cold snare, and hot snare polypectomy</li> <li>● Retrieves foreign body on endoscopy</li> <li>● Performs an esophageal dilation but doesn't recognize starting diameter</li> </ul>

<p><b>Level 4</b> <i>Independently performs peri-procedural assessment, including required diagnostic evaluation and selection of equipment in complex cases</i></p> <p><i>Independently performs the complete procedure to intended extent, including thorough visualization/ examination</i></p> <p><i>Independently performs standard therapeutic interventions</i></p>	<ul style="list-style-type: none"> <li>● Recognizes when to defer a procedure due to patient instability</li> <li>● Switches to a pediatric colonoscope if unable to get past a stricture</li>   <li>● Performs complete colonoscopy independently and meets established quality metrics</li>   <li>● Performs an esophageal dilation with appropriate selection of starting and concluding diameter</li> </ul>
<p><b>Level 5</b> <i>Efficiently performs the complete procedure to intended extent, including thorough examination/ visualization, in complex cases</i></p> <p><i>Efficiently performs complex therapeutic interventions</i></p>	<ul style="list-style-type: none"> <li>● Stays on time during a busy endoscopy day while performing all required interventions</li>   <li>● Independently removes polyps larger than 2 cm with lifting technique</li> </ul>

<b>Medical Knowledge 1: Clinical Knowledge of Gastrointestinal and Liver Diseases (Non-Procedural)</b> <b>Overall Intent:</b> To acquire, possess and demonstrate the facts, concepts and ideas related to the field of gastroenterology in order to provide patient care and communicate with other medical professionals	
Milestones	Examples
