

## **Osteopathic Neuromusculoskeletal Medicine Case Log System Review Committee for Osteopathic Neuromusculoskeletal Medicine**

The Review Committee for Osteopathic Neuromusculoskeletal Medicine (ONMM) has completed development of the ACGME Case Log System for ONMM. Residents in ACGME-accredited ONMM programs should begin logging all ONMM patient encounters, supervised by neuromusculoskeletal medicine-certified physicians, in the Case Log System. Residents in ONMM programs with statuses of pre-accreditation, continued pre-accreditation, and Initial Accreditation Contingent should also begin using the system. Residents should log patient encounters and procedures that occurred July 1, 2016 and after. The Review Committee will use the Case Log System to confirm that residents are achieving the patient encounters and procedures appropriate to their level in the program, as outlined in the Program Requirements. The Case Log System for ONMM is only available to residents in an ONMM program. Patient encounters and procedures may only be entered into the Case Log System if they occurred while in an ACGME-accredited ONMM program. Patient encounters and procedures completed in a primary residency or preliminary year must not be entered in the Case Log System for ONMM. It is, however, strongly encouraged that residents entering the program at the ONMM2 level maintain a log of ONMM encounters during the primary residency (see recommendation in the Osteopathic Neuromusculoskeletal Medicine [FAQs](#) document on the ONMM page on the ACGME website).

Programs and residents access the ACGME Case Log System through the Accreditation Data System (ADS). Several resources are available once logged in. User Instructions for how to assign residents usernames and passwords are located on the resident tab in ADS. The Case Log tab provides access to a number of Case Log reports, as well as to the Program User Guide and Resident User Guide.

Residents can access the Case Log System by clicking on the “Resident Case Log System” link in the top right-hand portion of the ACGME homepage. An ONMM-specific user guide is currently being developed.

Residents should provide the following information when logging an osteopathic neuromusculoskeletal medicine patient encounter supervised by a board-certified neuromusculoskeletal medicine physician:

- Date patient seen
- Attending
- Patient age group ( $\geq 18$  yrs and  $\leq 65$ ,  $\leq 18$  yrs, or  $> 65$ )
- Setting (inpatient or outpatient)
- Patient type, if applicable (continuity clinic panel patient, obstetrics and gynecology, pediatric, or surgical); more than one type may be selected for a patient
- Somatic dysfunction (more than one type may be selected)
- Treatment technique (more than one type may be selected)

Residents should also log any injection procedures performed during the patient encounter. The Review Committee will be tracking injection procedures with the following CPT codes: 20550, 20552, 20553, 20600, 20605, and 20610. Note: While a minimum number of injection procedures to be performed by program residents has not yet been established, residents must

still log these procedures. The Review Committee will use data collected to set a minimum in the future.
